## **NOTICE**

Subject : **Withdrawal of advertisements for filling up senior scientific positions on lateral entry basis** - regarding

The Board had notified the revamped score card framework for screening of applicants for lateral entry selections to senior scientific positions on 16<sup>th</sup> February, 2018.

It had also been mentioned that the Competent Authority has now decided that, henceforth, the screening and selection process for all lateral entry senior scientific positions shall be governed by the revamped score card framework.

Consequently, the Board has been directed to withdraw all the earlier advertisements for which the recruitment action has been kept pending due to the revision of the score card framework and issue fresh advertisements which shall be regulated as per the revised score card framework.

In pursuance of this decision, all the positions advertised earlier by the Board vide Advt. Nos. 03/2016, 04/2016, 05/2016, 01/2017 and 02/2017 except the five positions advertised vide Item Nos. 163 to 167 of Advt. No. 05/2016 stands withdrawn due to the above cited administrative reasons.

The Board shall be issuing fresh advertisements for all these positions shortly. The screening and selection shall now be regulated as per the revamped score card framework.

Such of those applicants who had applied in response to the earlier advertisements may apply afresh in response to the fresh advertisements, to be notified in the revised application format - 2018 as notified in the Board's website vide notice dated 20.2.2018. Such applicants need not pay the prescribed application fee again.

It is further clarified that as a one-time relaxation (which shall not be quoted as a precedent) the upper age limits and other eligibility conditions of all such applicants who had applied in response to the earlier advertisements shall be reckoned with reference to the respective closing dates / last date for receiving applications as mentioned in the earlier advertisements as detailed below :-
