# RESULT OF AGRICULTURAL RESEARCH SERVICE (PRELIMINARY) - 2016 AND NATIONAL ELIGIBILITY TEST (NET-I) EXAMINATION - 2017

Result of Agricultural Research Service (Preliminary) - 2016 and National Eligibility Test (NET-I) Examination – 2017, held during 16-21 May, 2017, has been declared and notified on ASRB's website www.asrb.org.in and ICAR's website www.icar.org.in. Total 2563 candidates have qualified in ARS (Prelim) -2016 and 6987 candidates have qualified in NET(I) examination-2017.
