### RESULT NOTICE - ARS MAINS EXAMINATION-2015

The Agricultural Scientists Recruitment Board (ASRB) conducted ARS Mains Written Examination-2015 on 08.05.2016. The provisional list of candidates qualified for viva-voce under 30 disciplines has been uploaded on ASRB's website [www.asrb.org.in](http://www.asrb.org.in).

2. The viva-voce dates are being notified separately. Candidates may regularly check Board's website for requisite updates. The Interview / Viva-voce call letters will be issued to the qualified candidates through their e-mail address given in the application form. Besides, SMS will also be sent on their registered mobile number. **Kindly note that no information / viva-voce call will be made by post.** If any candidate fail to receive the viva-voce e-mail 10 days prior to the date of viva-voce of the respective discipline, he/ she may contact the Examination-II Section, ASRB on phone no. 011-25848172 and 25840251 Extension 202 or e-mail to [soexam2@asrb.org.in](mailto:soexam2@asrb.org.in).
3. The appearance of a candidate in the viva-voce will be purely provisional. If at any stage, the Board finds that the candidate does not fulfil any of the prescribed eligibility conditions, his/her candidature is liable to be rejected. The candidates are also advised to go through the eligibility conditions as mentioned in the ASRB's Notification for ARS Examination-2015 [No. 14(1)/2015-Exam.I dated 09.10.2015]. If the candidates do not possess the required relevant documents/ certificates in support of their eligibility, they shall not be allowed to attend the viva-voce.
4. The candidates are advised to regularly visit the ASRB's website i.e. [www.asrb.org.in](http://www.asrb.org.in). All the information/updates related to ARS Viva-voce will be uploaded on the above mentioned website only.
5. The candidates are directed to bring the attested copies as well as original documents/certificates on the day of viva-voce. The list of documents/ certificates has been indicated in the exam notification under "Important Instructions for Candidates".
6. Candidate will not be allowed to appear in the viva-voce if he/she fails to produce any/all of the original documents/certificates. Also, he/she will not be given any extension in time for submission of any/all of the documents/certificates. A candidate himself/ herself will be responsible for any loss suffered by him/her due to non-adherence of these instructions and the Board will not be responsible for the same in any way.
7. No request for change in the date and time of the viva-voce will be entertained.
8. The candidates are advised to notify changes in their address, if any, to the Board immediately through Fax or letters forthwith.
9. While every care has been taken to ensure accuracy of the result, if at any stage, any discrepancy comes to the notice of ASRB, the Board reserves the right to rectify the same and no claim whatsoever will be entertained if any person/ candidate is affected in the process.
